About the Festival

The Trinkets & Treasures Holiday Festival is a multi-vendor fundraiser festival benefitting the FHS Marching Band & Color Guard. It follows a typical arts and crafts show format whereas vendors pay a booth fee plus show commission. This is a non-juried show....anyone can participate!

Cost

Vendors pay a booth rental fee based upon space size, in addition to donating 10% of their total sales in lieu of commission. Because the Ferndale Band Boosters is a nonprofit organization, booth fee plus the 10% donation is tax deductible. The rental fee helps the boosters pay for costs associated with hosting a festival and the 10% donation is the fundraiser.

Vendors

Individuals and businesses are invited to participate. Business licenses are not required except for food vendors. Vendors are allowed to have mixed items. Vendors may share booth space with family and friends without additional charge.

I understand and agree that failure to do either of the above may result in suspension from participating in future Trinkets & Treasures Festivals.

Indemnity Agreement

The vendor shall at all times hereafter indemnify and hold harmless Ferndale Band Boosters, Ferndale High School, AND Ferndale School District and its agents, employees, directors and officers, against any and all suits, actions, proceedings, claims, liabilities, and demands which may be made or alleged as a direct or indirect consequence of the vendor's activities, errors or omissions, of any kind whatsoever, resulting from or caused by the exercise by vendor of any of its rights under this agreement. This indemnity provision shall include all liabilities and losses including, but not limited to, claims of the vendor and/or third parties as may be asserted or made against Ferndale Band Boosters, Ferndale High School, and/or Ferndale School District directly or indirectly resulting from the sole or concurrent negligence of Ferndale Band Boosters, Ferndale High School, and/or Ferndale School District and/or damages of any kind whatsoever, including without limitation reasonable attorney's fees and court fees and court costs incurred by Ferndale Band Boosters, Ferndale High School, and/or Ferndale School District. If a court of competent jurisdiction rules invalid and/or unenforceable any of the provisions or interpretations of this indemnity clause, each of such provisions or interpretations ruled invalid or unenforceable shall be disregarded, but the remainder of this indemnity provision shall be given full force and effect.
